The exam covers the following ASTM Sections: C31 - Making Test Specimens; C138 - Unit Weight and Yield; C143 - Slump; C172 - Sampling; C173 - Air Content/Volumetric Method; C231 - Air Content/Pressure Method; and C1064 - Temperature.

ACI Grade I Concrete Field Testing Technician Examinees

You have applied to take an examination for certification by the American Concrete Institute as a Concrete Field Testing Technician Grade I.

This is a very difficult examination for anyone who is not thoroughly familiar with all of the referenced ASTM specifications and who has little experience in conducting the physical tests on concrete that are required.

This is not a training program. The exam is “closed book” and you will not be coached or given any assistance in conducting the physical tests. You will be graded on each step in conducting each test. Failure to perform any step in the procedure correctly will mean failure of that particular test. All seven tests must be performed correctly in order to pass the physical portion of the examinations.

The written examination is also “closed book”. Each examinee will have a different set of questions from the other examinees, so questions from former examinations may or may not appear on your examination. You must be very knowledgeable about each specification in order to pass the written portion of the examination.

Due to past experience in conducting these examinations, *we require that you attend the study workshop* scheduled prior to the examination *or submit the enclosed statement by your supervisor* that you have been trained “in-house” and are prepared to take the examination.
